## 6. Old Business:

- a. Voting to adopt "Principles of Collaboration" (Jill, Carmen);
  - i. Matter has been on the agenda for several months. In the interest of fairness committee has continued to pass the matter on to upcoming meetings in an effort to allow related parties a chance to vote, however parties have failed to attend meetings. Committee voted to remove item from agenda.
- b. Ad Hoc committee for Domestic Violence Accountability Program (DVAP) and Parenting Without Violence (PWOV) recourse (Jim, Linda, John, Brenda);
  - i. New affidavits were recently sent out to all providers with new protocols. Ad Hoc Committee meet with Honorable Judge Wilson to discuss current issues and will meet again on May 23 for additional updates.
  - ii. Ad Hoc expects more agencies to be attending BIC as part of new protocol, failure to do so will result in removal of court list.
- c. 16 week vs. 52 week program updates;
  - i. Group discusses batterer treatment outcomes and the issues with the CAP program since 2000.
  - ii. Discussion on having an independent group look at legality of and how other counties across the state are applying DV practices.

- iii. Is a tier system or other factors such as mental health considered? Group grapples with challenges of current legislation.
- iv. Committee discusses real/unreal expectations of a defendant in a 52 Week BIP.

#### 7. New Business:

- i. DV Retreat discussion;
  - 1. Discussion regarding county's current outlook that 52 Week Batterer Intervention Programs (BIPS) don't work.
  - 2. Conversation over victim vs. perpetrator dynamic as well as reality that this is a family violence problem since most parties want to remain in the relationship.
  - 3. Frank suggests group establish talking points that counter what works and doesn't work.
- b. Discussion of FY'17-FY'18 Workplan;
  - i. Obtain research to vouch for success and benefits of BIPs.
  - ii. Committee considers asking Office of Women's Policy (OWP) for funding to bring training to Santa Clara County (SCC) Northwest Network Seattle Training on Power and Control.
  - iii. Victim education as well as DV advocates in criminal court.
