Groups of speakers on a specific item are asked to limit their total presentation to a maximum of twenty minutes for each side of the issue.

This item is reserved for persons desiring to address the Subcommittee on any matter within the subject matter jurisdiction of the Subcommittee that is not on this agenda. Members of the public who wish to address the Subcommittee on any item not listed on the agenda should complete a request to speak form and give it to the Deputy Clerk. The Chairperson will call individuals to speak in turn.

Speakers are limited to the following: three minutes if the Chairperson or designee determines that five or fewer persons wish to address the Subcommittee; two minutes if the Chairperson or designee determines that between six and fourteen persons wish to address the Subcommittee; and one minute if the Chairperson or designee determines that fifteen or more persons wish to address the Subcommittee.

The law does not permit Subcommittee action or extended discussion of any item not on the agenda except under special circumstances. If Subcommittee action or response is requested, the Subcommittee may place the matter on a future agenda.
