

NOTICE TO BIDDERS

NOTICE IS HEREBY GIVEN that the County of Santa Clara will receive Prequalification Questionnaire Packages for Job Order Contract: JOC-RAD-2019-01 until 2:00 p.m. on Tuesday, September 10, 2019, at the Roads and Airports Department, 101 Skyport Drive, San Jose, CA 95110.

Instructions to Bidders and Contract Documents, including the Prequalification Questionnaire Package, Special Provisions, Construction Task Catalog, and Task Specifications, may be examined at the Plan Counter, County of Santa Clara Roads and Airports Department, 101 Skyport Drive, San Jose, CA 95110. A copy of the Prequalification Questionnaire Package can be obtained at no cost from the Plan Counter or by downloading from the Roads and Airports Department website at <http://www.sccgov.org/sites/rda>. Contract Documents for bidding can be obtained upon payment of \$100.00 per set to the plan counter. An additional \$15.00 fee is required to mail the documents.

This Job Order Contract (JOC) is an indefinite quantity contract pursuant to which the Contractor will perform a variety of projects, consisting of specific construction tasks, at various locations within the County. This JOC Contract is for road maintenance repair and other repetitive related work to be performed for the County of Santa Clara Roads and Airports Department. The County has published a Construction Task Catalog (CTC) containing a series of construction tasks with preset Unit Prices. All Unit Prices are based on local labor at the current prevailing wage rates, material and equipment prices. The scope of Work for this Contract will be determined by the Detailed Scope of Work issued in connection with individual Job Orders. The Contractor furnishes all management, documentation, labor materials and equipment needed to perform the work. The Job Order(s) issued pursuant to this solicitation will have, in aggregate, a minimum value of \$50,000 and a maximum value of \$2,000,000 with an option to increase the maximum contract value in the amount of \$1,000,000 for a total maximum contract value of \$3,000,000.

A mandatory prequalification conference will be held on August 27, 2019, at 10:00 AM at 101 Skyport Drive, Training Room, San Jose, CA 95110, for the purpose of discussing the prequalification questionnaire, questionnaire rating system, contractor's viewpoint and answering questions, and submission of completed questionnaire package. **All Contractors who intend to submit the Prequalification Questionnaire must sign in at the conference.**

Following the prequalification review period, a mandatory pre-bid conference will be held on a date and time to be determined at 101 Skyport Drive, Room 101, San Jose, CA 95110, for the purpose of discussing the JOC process, documents, bid considerations, JOC from the contractor's viewpoint and answering questions. The County's intention is to bid Job Order Contract: RAD-2019-01 shortly after the pool of prequalified contractors is selected. The prequalified contractors list will be valid for one year.
