We believe all of our students can learn at high levels, but if they are hungry, it makes it very difficult for them to concentrate and do their best. For some of our students, school meals are their only source for a nutritious hot meal. When we are supporting a child who's behavior is escalated, we ask if they have had breakfast and often the response is no. We see first-hand the transformation in the child's ability to focus in class and interact positively with his/her peers after having eaten.

Yet, the unique needs of Silicon Valley require greater investment and collaboration. Funding for our schools typically is directed at academics, but this important program recognizes the important role of nutrition and health in student success. Second Harvest of Silicon Valley is thrilled to write in support of the Universal Meals Referral.

One in three children in Silicon Valley is at risk of food insecurity. Feeding children at school is a crucial strategy to ensure that our students are fed and ready to learn and thrive.

This innovative referral would provide funding to allow local high-needs schools to take advantage of federal meals programs like the Community Eligibility Provision and Provision 2. These programs enable schools to feed every child a free breakfast and lunch, ensuring they have the nutrition they need for school success.

Santa Clara County would be in the vanguard of using local dollars to enable the use of even greater federal dollars. For every \$1 Santa Clara County invests, the federal government would be investing at least \$2 in feeding our children.
