**NEW BUSINESS**

7. PEACE Partnership presentation on clinics healthcare response to DV:  
Maritza Rodriguez started out by explaining the funding received in 2016 for Public Health from California Accountable Communities for Health Initiative (CACHI). The model is to transform community's health by building more expansive and prevention-oriented system. It was decided that they would focus their efforts in East San Jose in the 95116, 95122 and 95127 zip codes to address community violence and trauma. The PEACE Partnership is overseen by a leadership team made up of representatives of many groups.

The Santa Clara County Public Health Department staffs the partnership and provides support and guidance. Most work is done by six work groups:

- Anti-Displacement Work Group
- Clinics for PEACE Work Group
- Financing Sustainability Work Group
- Promoters to prevent Intimate Partner Violence Work Group
- Gun Safety and Violence Prevention Work Group
- Youth Leadership and Place-Making Work Group

Next Door Solutions are one of the partners of PEACE Partnership and they are working on two of the work groups.

Vanessa Bolton explained that it's a requirement to have a Clinics for PEACE Work Group. The idea is to bring together clinics and address the issue of violence in the community. The work group agreed to focus on IPV. If you set the foundation for IPV within the clinics, you set the foundation to address other issues such as human trafficking, sexual assault, ACES, etc.

There is a meeting on November 19<sup>th</sup> to present some of the work PEACE Partnership has been working on with clinics addressing issues. The focus will be on IPV. The meeting will be held at 1775 Story Road, Ste. 120 from 8:30am to 11:30am.

Vanessa explained that they feel we need to have a Champion within our County that is innovated and can speak to their colleagues about anything related to IPV.

Esther from Next Door explained that private sector clinics and community-based clinics are the people that Next Door are interacting with and they are calling and asking for mandated reporting.

Laura Brunetto will commit to attend the November 19<sup>th</sup> meeting. Suzanne Frank would like to bring people from other clinics.

There were three DV strangulations last week.

Kim Walker spoke about getting the strangulation protocol started, the DV Medical protocol, and the strangulation pilot starts in the next couple months. Next Door will be part of it too.

Erica from Next Door mentioned they are piloting a project in East San Jose called Coaching Boys into Men and as business leaders. Leveraging the relationship that athletic coaches have with their athletes, both male and female and they incorporate within their coaching sessions, a 15-minute session for 12 weeks around healthy relationship building skills. This is done through the PEACE Partnership.

Liliana Hamlett will be presenting Stop Domestic Violence forum on October 10<sup>th</sup> at Valley Medical Center in the 2<sup>nd</sup> floor cafeteria from 8:00am to 10:00am and would like for Next Door and PEACE Partnership to attend. She will show a video that they may be interested in using.
